- 3. Complete the permission slip and ask a teacher, school counselor, or a staff member of the LGBT Center Orange County to scan and e-mail it to: TimeToThrive@hrc.org. The 100 free slots are expected to quickly fill up! We highly recommend you submit your signed permission slip right away!
